PURPOSE

To provide guidance for using the 2024 Maryland Department of Transportation State Highway Administration (SHA) Standard Specifications for Construction and Materials (2024 Specifications Book). The 2024 Specifications Book will be adopted for use on July 1, 2024.

SUMMARY

The 2024 Specifications Book is a compilation of the 2023 Specifications Book; new or revised Special Provisions Inserts (SPIs) approved for use between July 1, 2023, and April 30, 2024; and reference or typographical corrections to the 2023 Specifications Book.
