

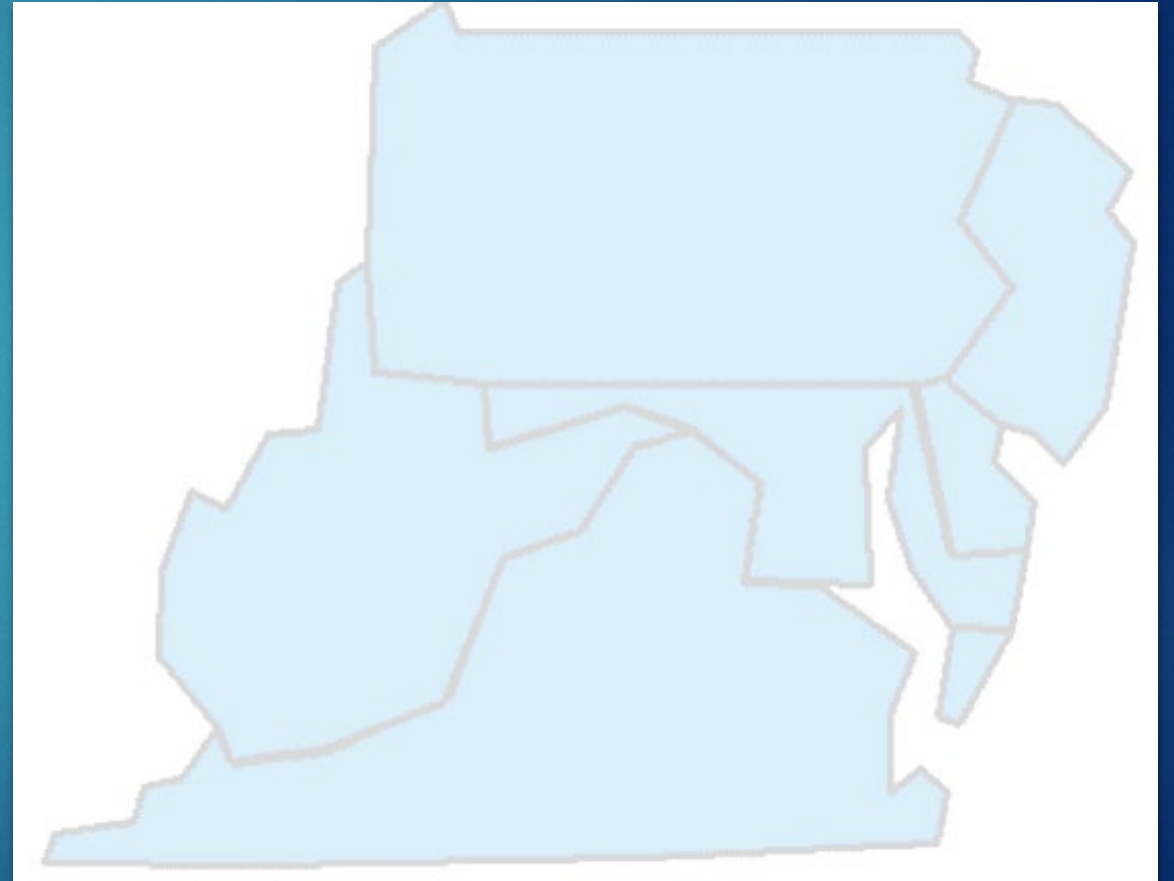

Application for Asphalt Field Technician Training Written Exam or Retest

Only technicians who have registered and paid for their HMA Field Online Training and have completed the training within 45 days will be allowed to register and take the examination. The Asphalt Field Technician Exam will be conducted in person at the MDOT SHA's Office of Materials Technology. Technicians must arrive 15 minutes before the selected exam time. It is a 2hr, open book exam with 60 questions. You must have a calculator and manual. No cell phones or other electronic devices are allowed.
